U.S. BARGE INKS FIRST DEAL

Company co-owned by Oregon Iron Works and Vigor Industrial to deliver barges in 2007

PORTLAND, Ore. (September 5, 2006) – U.S. Barge LLC, a company co-owned by Oregon Iron Works, Inc. (OIW) and Vigor Industrial LLC, today announced that it has signed a contract for its first order. The company has agreed to build and deliver multiple “blue-water,” or ocean-going, barges to Young Brothers, Ltd. in Hawaii, with the first barge to be delivered in late September of 2007.

“I am ecstatic that, with this venture, we bring Swan Island back to its roots in vessel construction: Ships were built here during World War II. The Port of Portland deserves serious credit for their foresight in making decisions to keep the shipyard open for marine and industrial purposes,” said Vigor Industrial President Frank Foti.

“I am also delighted to partner with Oregon Iron Works. It has a well-deserved reputation for quality work and more importantly has great people who make it all happen. These traits combined with our resourcefulness and marine experience make for a great match.

“We look forward to supplying barges to Young Brothers, Ltd. and other clients for many years to come,” Foti added.

Oregon Iron Works Chairman Terry Aarnio said, “Our joint undertaking with Vigor Industrial holds great promise. We always take the innovative approach – this alliance and the building of these barges are no exception.

“We are very pleased to have the opportunity to bring new ocean service barge construction work to Swan Island. We’re confident that there are excellent prospects for U.S. Barge in the current marketplace and expect this market to grow substantially in the

next decade. Swan Island is an ideal location that has the essential physical facilities and infrastructure to support our anticipated growth,” Aarnio added.

U.S. Barge will invest approximately \$8 million in new equipment on Swan Island and in Clackamas, OR in order to build barges and other watercraft.

I know the workers and management of U.S. Barge will succeed in serving an important market and that their efforts will make Oregon’s economy stronger.
